- The Members of the Council and the Guests will be seated in the Council Chamber, Municipal Buildings, Middlesbrough prior to 7.00 p.m.
- 2. The Worshipful the Mayor (Councillor Frank Platt) preceded by the Mace, and followed by the Proposers and Seconders of the Resolutions (Councillor Bob Brady and Councillor Malcolm Pritchard for Councillor Walter Ferrier MBE, Councillor Peter Jackson and Councillor Mrs. Barbara Grant for Councillor Gwendoline Popple and Councillor Ken Hall and Councillor Norman Swash for Councillor Leonard Poole BEM JP) who will escort the said Councillor Ferrier, Councillor Popple and Councillor Poole to their seats.
- The Mayor will call upon the Borough Secretary to read the Notice convening the special meeting of the Council.
- The Mayor will call upon Councillor Bob Brady to propose and Councillor Malcolm Pritchard to second a Resolution to admit Councillor Walter Ferrier MBE to the Honorary Freedom of the Borough.
- 5. After the resolution has been proposed and seconded it may be spoken to by other Members of the Council.
- The Mayor will call upon Councillor Peter Jackson to propose and Councillor Mrs. Barbara Grant to second a Resolution to admit Councillor Gwendoline Popple to the Honorary Freedom of the Borough.
- 7. After the Resolution has been proposed and seconded it may be spoken to by other Members of the Council.

- The Mayor will call upon Councillor Ken Hall to propose and Councillor Norman Swash to second a Resolution to admit Councillor Leonard Poole BEM JP to the Honorary Freedom of the Borough.
- After the Resolution has been proposed and seconded it may be spoken to by other Members of the Council.
- 10. The Mayor will put the Resolutions to the Meeting, and after the same have been declared carried, the Borough Secretary will read the Oath of the Freedom as follows:

"Do you, Walter Ferrier, Gwendoline Popple and Leonard Poole swear to be true to our Sovereign Lady Queen Elizabeth II, Her Heirs and Successors, as a free and franchised person of this Borough?

Will you preserve the peace and tranquility of the said Borough, and will you disclose to the Mayor for the time being details of any unlawful meetings or assemblies which come to your attention?

Will you do all in your power to contribute to the good government and safety of the said Borough and the inhabitants thereof?

Will you also defend the customs and privileges of this Borough in every just and lawful cause?

SO HELP YOU GOD".

- 11. Councillor Walter Ferrier MBE, Councillor Gwendoline Popple and Councillor Leonard Poole BEM JP signify acceptance of the Oath by replying, in turn, I WILL. The Mayor will then invite them to sign a copy of the Oath and the Roll of Admissions of Freedom. The Signatures will be witnessed by the Mayor, Chief Executive and Borough Secretary.
- 12. After the signing of the Roll, the Mayor will present sealed and illuminated copies of the Resolution inscribed on vellum, together with caskets, and will offer congratulations on behalf of the Corporation and People of the Borough.
- 13. Councillor Walter Ferrier MBE will reply.
- 14. Councillor Gwendoline Popple will reply.
- Councillor Leonard Poole BEM JP will reply.
- 16. The Borough Secretary will report the receipt of any communications.
- 17. At the conclusion of the formal proceedings, the Mayor will leave the Council Chamber accompanied by all those present holding the Freedom of the Borough.


