1.	Overview / Update on Government funding opportunities: Future High Streets Fund / Towns Fund / Brownfield Homes Fund – <i>Kevin Parkes</i> <i>(verbal)</i>
	KP advised that the Future High Street Fund bid has been submitted for £20.5m.
	Government recently launched a Brownfield Homes Fund with £19m allocated to TVCA who are working with the 4 Boroughs to put submissions together. Middlesbrough put forward 7 schemes.
	AP enquired when we would hear back regarding the Brownfield Homes Fund SG advised that the TVCA allocation of £19m has been approved but there is some breakdown and distribution from Tees Valley and currently waiting to hear. AC currently doesn't have any information but will find out and report after the meeting. AP stressed that they would like to hear asap on when and how much Middlesbrough will be getting.
2.	Future High Streets submission (Circulated for comment)
	AP invited people to ask questions.

	AMcD enquired about capacity and finding alternative locations for businesses to relocate. SG explained that due diligence regarding acquiring the Captain Cook Square had taken place. Also the Council are in regular dialogue with businesses. Some main companies are looking to downsize and discussions are taking place to ensure businesses are kept in the town.
	SC enquired about the timelines and the plan over the next year. AP advised of exciting plans with a major leisure provider. SG advised that they are working through the leases.
	SC asked about the House of Fraser building and would it remain a retail outlet. AP advised of some ideas and aspirations regarding the building and the need for a quality retailer and the need for rental income.
3.	Towns Fund draft overview of submission – Sam Gilmore
	SG advised that for cohort 1 submissions were due by the end of July. A presentation was shared.
	TP enquired how strong the public engagement process was. SG advised that engagement has taken place through the MyTown website and a great deal of previous consultation/engagement data was used to develop the projects in the submissions,
	KP advised that further community engagement is ongoing and will form a key role of the Board. SG/TS/KP to discuss further offline.

	Marc Watterson shared screen and advised they are aiming for early cohort and are to support the town in the bid. Middlesbrough advanced compared to other towns.

For Debate – Recommended Reductions

Theme / Project	Reasoning	Saving Requirement	£3,100,000
Urban Living	The maximum Urban Living theme allocation available is £15.75m (or 72% of the £21.9m programme offer). Whilst some schemes are well developed, others require more detailed market engagement and modelling to progress. A non-specified reduction of £1.875m would retain a theme budget of £13.875m and would still represent > 63% of the overall programme.		-£1,875,000
Centre Square - Integration	This project aimed to drive links between the Centre Square office quarter and the town centre. This would largely seek to improve links via the Cleveland Centre. This requires third party cooperation and the funding allocation is unlikely to cover the opportunity cost of displaced floor space / rents. As such, the funding is deemed insufficient to ensure delivery certainty.		- £225,000
Town Centre Animation and events	This project was earmarked to make provisional adaptations to the Town Hall (Civic Spaces) and Middlesbrough Central Library, to promote public use and deliver an additional range of public / cultural services. This funding contribution was contingent upon a significant amount of match funding being sought from internal / external sources; and is insufficient to deliver the full scope of adaptations required.		-£1,000,000



Fast Track Process

- MHCLG Offer Letter Sets out themes eligible for fast-track support.
- Only applies where meaningful investment can commence or occur within the first 3 months (Oven Ready).
- For Middlesbrough, the only candidate identified was Knowledge Economy – College Campus Enhancements.
- Further Business cases will be developed over the coming months and considered by the Town Deal Board in detail.
- RECOMMENDATION Approve College Fast-Track funding, subject to business case and MHCLG agreement.

- Revised programme (£) and detailed Heads of Terms agreed with MHCLG by - end of April 2021
- Detailed Business Cases developed by project leads and brought for Board Consideration – From May 2021
- Middlesbrough Council Executive Programme Endorsement May 2021

Minutes from previous meeting
Minutes of last meeting agreed as a true record.
Membership / Admin changes confirmed
Following Kevin Parkes retirement, it was agreed that Richard Horniman Director of Regeneration and Culture would take his place on the Board; in a non-voting capacity.
Board administration / voting rights and quorum
Andrew Perriman, the Council's Head of Legal Services was invited to discuss the administration of the board and ensure a system was in place for any Board members to declare their interests in any decisions taking place. It was agreed that Andrew would review and rewrite a Constitution for the board.

	Revised programme and fast track preferences debate			
	Sam Gilmore delivered a presentation detailing the programme of funding submitted and details of the funding Middlesbrough was awarded. Funding applied for was £25m and funding received was £21.9, therefore the programme needs to be reduced by £3.1m. The presentation made a number of suggestions on how the reductions could be made, based on how developed each of the projects are. The Board agreed the savings proposals debated.			
	£1.875m would be withdrawn from the Urban Living programme			
	£225k was removed from Centre Square Integration			
	£1m was removed from the adaptation/consolidation of Civic spaces at the Town Hall and Central Library.			
	The Towns Fund programme allows for projects to be fast tracked, as the Building a Knowledge Economy has a requirement to start on site in the next month, it was suggested that it be put forward for fast track.			
6.	Middlesbrough College presentation			
	Further to the above fast track project, Zoe Lewis gave a detailed presentation on the overall developments at Middlesbrough College and the contribution the Towns Fund resource will make.			
	The Board approved Middlesbrough College's Expansion programme, investment of \pounds 1.175m, to be fast tracked, given its advanced progress. This decision commits the funding subject to completion of the detailed business case documentation.			
7.	Next steps and Timescales			
	By early May, key documentation needs to be completed detailing the amount each project requires, outputs and outcomes and how conditions of funding will be met etc. and submitted to MHCLG.			
	Business cases can then be written for each project and submitted to the Board for local assurance and sign off, once these are agreed summary documents will be collated and submitted to MHCLG to access payment.

	Tony Parkinson would like a strategic overview of how the Towns Fund fits with other key funding streams to be presented at the next Board meeting.
