HMS Marlborough, a Type 23 Frigate, has combined its role in the defence of our country with the promotion of our town in places where even the Riverside Stadium is an unfamiliar venue.

to the Honorary Freedom of the Borough on Wednesday, 15th March 2000 at Eleven O'Clock

- The Members of the Council and the Guests will be seated in the Council Chamber Middlesbrough prior to 11.00am.
- The Worshipful the Mayor (Councillor Michael J Carr) preceded by the Mace will take his seat.
- 3. The Mayor will call upon the Chief Executive to read the Notice convening the special meeting of the Council.
- The Mayor will call upon Councillor Oliver Johnson to propose and Councillor John Jones to second a Resolution to admit HMS Marlborough to the Honorary Freedom of the Borough.
- 5. After the Resolution has been proposed and seconded it may be spoken to by other Members of the Council.
- The Mayor will call upon Councillor Ken Walker to propose and Councillor Sylvia Connolly to second a Resolution to admit Mrs Alma Collin to the Honorary Freedom of the Borough.
- 7. After the Resolution has been proposed and seconded it may be spoken to by other Members of the Council.
- 8. The Mayor will put the Resolutions to the Meeting, and after the same have been declared carried, the Chief Executive will read the Oath of the Freeman as follows:

"Will you, Alma Collin, swear to be true to our Sovereign Lady Queen Elizabeth II, Her Heirs and Successors, as a free and franchised person of this Borough? Will you preserve the peace and tranquility of the said Borough, and will you disclose to the Mayor for the time being details of any unlawful meetings or assemblies which come to your attention?

Will you do all in your power to contribute to the good government and safety of the said Borough and the inhabitants thereof?

Will you also defend the customs and privileges of the Borough in every just and lawful cause?"

"SO HELP YOU GOD".

- 7. Mrs Alma Collin will signify acceptance of the Oath by replying, "I WILL." The Mayor will then invite Mrs Alma Collin to sign a copy of the Oath and invite both Mrs Alma Collin and the Captain of HMS Marlborough to Sign the Roll of Admissions of Freedom. The Signatures will be witnessed by the Mayor and the Chief Executive.
- After the signing of the Roll, the Mayor will present a sealed and illuminated framed copy of the resolution inscribed on vellum, and will offer congratulations on behalf of the Council and People of the Borough.
- 9. The Mayoress will present a bouquet to Mrs Alma Collin.
- 10. Mrs Alma Collin and Captain Rix of HMS Marlborough will reply.
- 11. The Head of Local Democracy Unit will report the receipt of any communications.
- 12. At the conclusion of the formal proceedings, the Mayor will leave the Council Chamber.
- 13. An Invitation is extended to the Members of the Council and Guests to then adjourn to the Boulevard to watch the Freedom Parade and then to Lunch to be held in the International Centre.
