

NOTICE OF ELECTION

Election of a Police and Crime Commissioner for Cleveland Police Area

1. An Election is to be held for a Police and Crime Commissioner for the Cleveland Police Area which incorporates the Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees voting areas.
2. Nomination papers can be obtained from the Police Area Returning Officer Room 65, Municipal Buildings, PO Box 11, Church Road, Stockton-on-Tees, TS19 1UE (sat nav) between 10am and 4pm on any working day.
3. Nomination papers must be delivered to the Police Area Returning Officer, at Room 65, Municipal Buildings, PO Box 11, Church Road, Stockton-on-Tees, TS19 1UE (sat nav), between 10am and 4pm on any working day after publication of this notice but no later than **4 pm on Thursday 8 April 2021**.
4. A deposit of £5,000 must be paid for each candidate by the deadline for delivery of nominations either by the deposit of legal tender (cash in British Pounds only), by means of a United Kingdom banker's draft or by an electronic bank transfer direct to Stockton-on-Tees Borough Council using Sort Code 55-61-00, Account Number 07436998 and quoting your name. Further details are available from Electoral Services, Room 65, Municipal Buildings, PO Box 11, Church Road, Stockton-on-Tees, TS19 1UE (sat nav).
5. Each candidate may provide an election address to the Police Area Returning Officer for publication on a website provided by the Minister. Full details can be found on the Election Addresses Notice published by the Police Area Returning Officer
6. If the election is contested the poll will take place on **Thursday 6 May 2021**.
7. The spending limit for the regulated period is a maximum amount of £76,889
8. Applications to register to vote must reach the relevant Electoral Registration Officer by 12 midnight on **Monday 19 April 2021**. Applications can be made online:

9. Applications, amendments or cancellations of postal votes must reach the Electoral Registration Officer by **5 pm on Tuesday 20 April 2021**.
