

**THE COUNCIL OF THE BOROUGH OF MIDDLESBROUGH
(OFF STREET PARKING PLACES) CONSOLIDATION ORDER 2017
AMENDMENT ORDER No. 4 2020**

NOTICE is hereby given that the Council of the Borough of Middlesbrough proposes to make an Order under Sections 32 and 35(1) of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act, and of all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act.

The effect of the Order will be to amend the Schedules of The Council of the Borough of Middlesbrough (Off Street Parking Places) Consolidation Order 2017 as listed in the Schedule hereto. Exemptions will apply to any vehicle to be used for emergency purposes by the fire brigade, ambulance or police.
