### **Section 14(1) of the Road Traffic Regulation Act 1984 (RTRA 1984) and regulation 3 of the Road Traffic (Temporary Restrictions) Procedure Regulations 1992 (SI 1992/1215)**

#### **THE COUNCIL OF THE BOROUGH OF MIDDLESBROUGH SANDY FLATTS FOOTPATH CYCLEWAY TEMPORARY PROHIBITION OF TRAFFIC ORDER 2020(Order)**

1. The Council of the Borough of Middlesbrough (Council) gives notice that it proposes to make an Order under section 14(1) of the RTRA 1984 and any other enabling powers over an area of the highway being a Footpath/Cycleway from Ladgate Lane to its junction with another highway at Grid Ref NZ 49491 / 16511 at Sandy Flatts Acklam, shown by a solid Black line on the plan TTRO-2020/1/SF attached to the Order (Plan).
2. The Order is needed to enable construction traffic and deliveries to gain access to a construction site.
3. If the Order is made, the Order shall come into operation on 8<sup>th</sup> June 2020 for a period of 24 weeks. The duration of the Order can be extended with the approval of the Secretary of State for Transport.
4. While the Order is in operation:

The Highway will be temporarily closed and alternative routes will be signposted. Access will be maintained, whenever reasonably possible, on the affected length of highway and appropriate signs will be displayed to indicate when the measures are in force. The highway will re-open as soon as the work is finished. This may be earlier than advertised.

Nothing in Article 2 above shall apply to the following:-

- (1) Any person being an owner, lessee tenant or occupier of those premises adjoining the said length(s) of road
- (2) Any vehicle to be used for the purpose of delivering or collecting postal packages as defined in Section 87 of the Post Office Act, 1953;
- (3) Any vehicle to be used for fire brigade, ambulance or police purposes
- (4) Any vehicle, if it cannot conveniently be used for such a purpose in any other road, to be used in connection with any of the following operations, namely:-
  - (i) Building, industrial or demolition operation;
  - (ii) Removal of any obstruction to traffic;
  - (iii) The maintenance, improvement or re-construction of the said sides of road or lengths of road;

- (iv) The laying, erection, alteration or repair in or in land adjacent to the said sides of road or lengths of road, of any sewer or main pipe or apparatus and the supply of gas, water or electricity or of any telegraphic apparatus as defined in Schedule 2 of the Telecommunications Act 1984
  - (v) In the service of a local authority or a water authority pursuant of statutory powers or duties
- 5. An alternative highway will be available for use while the Order is in force being the highway which runs along Ladgate Lane to the Blue Bell Pub then along Acklam Road to the Avenue of Trees. The route then runs behind Acklam Crematorium to its junction with the footpath / cycleway at Grid Ref NZ 49491 / 16511 at Acklam shown by a dashed Black line on the Plan (TTRO-2020/1/SF).
